With a quorum present, Mayor Eubanks called the meeting to order at 6:35 p.m. Council Member Davis gave the invocation.

#### **REGULAR SESSION-LED BY MAYOR EUBANKS**

#### APPROVE THE AGENDA

Council Member Davis made a motion to approve the agenda as presented, seconded by Council Member Shiver. The vote was unanimous.

#### **CITIZENS COMMENTS**

Felisha Draggs spoke to the council about how to help kids within our community. How to build the community to have more. She spoke about how to improve the activities for the youth and how she would like to see more for the kids. She also wanted to let the council know she is vested in the community and is willing to help wherever she is needed.

#### **COMMUNITY WORK PROGRAM**

The comprehensive plan, also known as a general plan, master plan or land-use plan, is a document designed to guide the future actions of a community. It presents a vision for the future, with long-range goals and objective for all activities that affect the local government. This includes guidance on how to make decisions on public and private land development proposals, the expenditure of public funds, availability of tax policy, cooperative efforts, and issues of pressing concern, such as farmland preservation or the rehabilitation of older neighborhood areas.

#### Recommendations:

- Under the Economic Development objectives section remove marketing program targeting retirement population and add development of the City's Industrial Park.
- Under Housing Objectives remove the feasibility study for Coates & Clark property for retirement/assisted living and add purse state funds to rehab dilapidated homes in the city.
- Under Community Facilities remove revive neighborhood watch programs and add rehabilitation of our local library and the development of a community center.
- Under Transportation edit improve Curry Street to provide aesthetic link to Hwy. 19 (Gateway Grant), to say improve aesthetic link to Hwy. 19.

**Council Member Brown made a motion** to update the Community Work Program from the recommendations received from City Manager Drake, **seconded by Council Member Robinson**. **The vote was unanimous.** 

#### **EXECUTIVE SEESION**

Council Member Davis made a motion to enter executive session, seconded by Council Member Brown. The vote was unanimous. Mayor Eubanks stated the purpose of the executive session is to discuss personnel. The meeting was closed at 7:15 p.m.
