EXECUTIVE SESSION

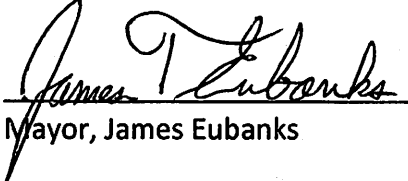

RECONVENE SESSION

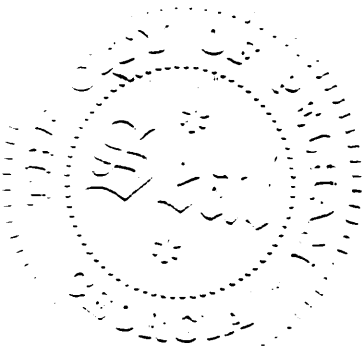
